5. Physical Delivery of Securities & Commodities - 0.25% of turnover

1. Client Unpaid Securities Pledge Accounts (CUSA) Transaction Charges - Rs.20 (Per Instruction)
2. Delay Payment Charges 18% per annum
3. For Physical Statements, Rs.10 per page plus postage charges
4. Due Diligence / Document Verification Charges in connection with the transmission of securities other than to the nominee's account - Charges as Applicable
